Secure Onsite Data Erasure for an International Financial Institution

Challenge

Their strict non-release of data-bearing assets policy mandated that all data destruction must occur onsite at their London headquarters, ensuring that sensitive information never left their premises.

However, their existing process was inconsistent, lacked detailed reporting, and did not provide the assurance needed to satisfy internal auditors and regulatory requirements. They required a solution that guaranteed complete data eradication with transparent, auditable records.

Solution

Key actions included:

- ▶ **Deployment of Ziperase:** Astralis utilised our ADISA-certified data erasure software, Ziperase, to securely and permanently erase data onsite, ensuring compliance with the institution's stringent data security policies.
- ▶ **Comprehensive Asset Scanning:** Every data-bearing asset was individually scanned and recorded before erasure, providing a complete and accurate inventory. This ensured full accountability and traceability throughout the process.
- ▶ **Onsite Data Erasure Team:** A dedicated team of security-cleared specialists conducted the data erasure at the client's secure London headquarters, ensuring no data-bearing devices left the premises.
- ▶ **Failed Drive Management and Physical Destruction:** In instances where a drive failed to erase successfully, it was immediately removed and destroyed onsite using Astralis' mobile shredder. This ensured 100% data destruction and compliance with the non-release policy.
- ▶ **Real-Time Reporting and Certification:** Detailed erasure reports were generated in real-time, including a full inventory of scanned assets and confirmation of successful data destruction. All reports and certificates were provided before leaving the site, ensuring complete transparency and compliance.
